1. Information we collect

In operating our Website, we may collect and process the following data about you:

3. On occasion, we may gather information about your computer for our services, and to provide statistical information regarding the use of our Website to our advertisers.

Such information will not identify you personally; it is statistical data about our visitors and their use of our site. This statistical data does not identify any personal details whatsoever. It is used by us to analyse how visitors interact with the Website so that we can continue to develop and improve this Website.

We may gather information about your general Internet use by using a cookie file that is downloaded to your computer. Where used, these cookies are downloaded to your computer automatically. This cookie file is stored on the hard drive of your computer as cookies contain information that is transferred to your computer's hard drive. 4. Use of your information

- If you do not want us to use your data for ourselves, you have the right to withhold your consent to this when you provide your details to us on the form on which we collect your data.
- Please be advised that we do not reveal information about identifiable individuals to our advertisers or other organisations; however, you have the right to grant us permission to pass this information on to another organisation.

5. Storing your personal data

- Data that is provided to us is stored on our secure servers. Some techniques we employ to protect information include, but not limited to, locked files, user authentication, encryption, firewall technology and the use of detection software.
- The transmission of information via the internet is not completely secure and therefore we cannot guarantee the security of data sent to us electronically.
